

LETTER TO EDITORS

It was with a certain amount of sadness that we read Mr NASH's letter in last month's News and Views.

Sadness for a number of reasons:

- Because a 'them and us' situation now seems to exist
- 2. Because a simple question put to the elected Parish councillors about planning questions should be construed as giving them 'a hard time'
- 3. Because we should all be working for the same cause but seem not to be

It is true that the question about the planning came from people who have not lived in Kenn all their lives. Maybe the 'newcomers' feel that living in a quiet rural community is something to be cherished and fought for, whereas those

who have been here for longer are becoming complacent.

Three items of major planning concern have come up over the last few years: 1) the equestrian centre, 2) the football club and 3) the traveller's site.

The equestrian centre could fairly be described to be suitable for a rural commnuity. Horses and riders fit in well and it is doubtful if any of the villagers object to the slight disruption of road traffic this causes in and around the centre. It becomes more doubtful if the associated activities, such as rock and jazz festivals belong here. Someone at the meeting put forward the notion that the people running the centre would not be able to make ends meet unless activities other than those for which the centre was created were allowed. This, frankly, is their problem, and we do not accept that for commercial reasons our quiet rural lives should be disrupted.

The football club was the main bone of contention. Reading Mr Nash's letter one might be forgiven for getting the impression that the question put caused unruly behaviour at the meeting. This was far from the case. A simple question about why the Parish Council had raised no objections to the planning application was met with what seemed to be embarrassed evasion. A football club does, perhaps, belong in the countryside if the club served the local community. In this case it serves a neighbouring town and has nothing whatsoever to offer our village, except the possibility of noise, traffic and rowdiness. Obviously we were disappointed that no objections were raised.

Even if the football club is a suitable candidate for being in our community, the permission to let them be here raises the uncomfortable question of precedence. If they can get permission what is to stop other developments from taking place. Perhaps it would be an idea if in future any planning applications that

she thought might prove useful; to Roger WILCOX who wrote numerous letters; to Roger and Margaret STOWELL for the unlimited use of their photocopier; and to Stuart AUTY who prepared a special report detailing objections to the proposal.

In addition, we are grateful to Maurice BLIGHT who gave us the full backing of the NFU; and to Fred ELLIMAN, the Director of the North Somerset Archeological Research Group, who spent many hours of his spare time searching the field for artifacts, and whose find of Roman coins and pottery was one of the main reasons why this site was rejected.

NEIGHBOURHOOD WATCH

The meeting of the district co-ordinators of the Neighbourhood Watch Groups was held at Hangstones, Yatton on Wednesday 20th May. Over thirty attended coming from Cleeve, Claverham, Yatton and Kenn. PC Keith HARRIS the area's policeman was in charge.

The responsibility for the area's groups has been passed to WPC Sharon BALL. PC Harris is stationed at an office in Yatton High Street and has been joined by PC Cooper. It is hoped that this office will be manned for callers for a couple of hours a week for any queries. Unfortunately with a force of two that presence will be stretched rather thinly. All cases of suspicious activities should be addressed to Weston-super-Mare 635252 or 999 if urgent.

During this hot weather it should be stressed that all doors and windows should be kept locked even when in the house or garden and doors locked and windows closed when it is unattended even for a few minutes.

One of the main items at the meeting was one of communication. So that groups may be better informed it was decided to try to join several groups under their

co-ordinators with a senior co-ordinator in charge. Information is passed from the police to the senior co-ordinator of the area and he will pass on that information to his group co-ordinators as necessary. In my young days it was called pinnacle tiers of management.

At present we have three groups in Kenn covering Kenn Street and Duck Lane. It should be possible for us to have more groups in Kenn, say Kenn Road from Willow Cottage to Kenn Court estate cottages, Kenn Court to Honeysuckle Cottage and at Kenn Pier. Should any person wish to be co-ordinator in these areas would they like to contact me on 877392 or the Parish Council.

Sheila thought that she'd already heard the cuckoo earlier than this but was accused of being cuckoo herself - or overworked!!! (Big Ed)



RARE OCCURENCE

Looking through some old Church records recently I came across the following.

1922. The Annual Vestry Meeting was held in Kenn Church, the reverend Walter PERKS was in the chair. After opening the meeting and thanking those present for their work for the church during the last year he then nominated Mr Frank DYER of Kenn Court as Vicar's Warden for the coming year. Mr Tom DYER of Kenn Pier Farm was then nominated by an unnamed person and seconded by Mr John JAMES as People's Warden for the coming year. Thus two





brothers were wardens for 1922 which must be very rare.

In those days it was the custom to call Church Wardens Vicar's or People's Wardens; one representing the Vicar the other the people. Thankfully this has now been dropped and both have equal status.

The Reverend Walter PERKS was Vicar here for about 25 years at the beginning of this century. I have been told he was a very small man with a very large wife. They travelled about the district in a horse drawn coach, their coachman was Mr WAYMAN whose grandson Ivor COX still lives in Kenn.

could be even vaguely described as being of a controversial nature were automatically opposed pending consultation. This seems to be what other villagers do, notably Keevil, where the putting up of five lamp posts was put to a referendum!

The travellers site is now mercifully out of the way, thanks mainly to the efforts in particular of a couple of the so called 'newcomers' to the village who attended every meeting of the Travellers Sub-Committee at Avon House. They never relaxed the pressure - they wrote at least 70 letters each, badgered Avon County Council, bombarded the sub committee with telephone calls and letters, wrote to every conceivable nature and conservation association to enlist their help. Reports by a nature society and the findings of an amateur archeologist carried a lot of weight. It was a hard fight they were sometimes in despair - but they never gave up. ON 8TH MAY THE SITE WAS THROWN OUT. We were informed upon enquiring that it was rejected on ecological and archeological grounds!

Finally the question of 'deafening silence' from the newcomers to the village when it comes to standing for office. Perhaps this is because the newcomers respect the implied prerogative of the people who were born here to govern village life. This reticence does not imply disinterest in the welfare of the village, as the battle to abolish plans for a traveller's site has proved.

LETTER TO EDITORS

We have received the following anonymous letter.

Following on the remarks in last months magazine by the parish council, regarding the fouling of Kenn Street and Duck Lane by dogs, I was very pleased to see that you had brought this matter to the attention of our dog owners.

I am enclosing a letter found in a magazine recently on the same matter, (obviously not all of it will need to be printed) which emphasises the health hazards of dog fouling.

I would like to draw your attention to the LARGE amounts of Horse manure we are forced to put up with in Kenn Street and Duck Lane since the opening of the Equestrian Centre and stables in Kenn. Why should we have to put up with the unnecessary fouling of our roads!! Horse manure is easily removed by the horse owner, might I suggest by either a bag attached under the tail of the horse, (as used to happen when there were large numbers of horses in our towns) or by carrying a SUPER POOPER SCOOPER and cleaning up as they go along, instead of leaving it to get on our shoes, clothes, bikes and cars, which then have to be scraped and washed in order to remove the sticky MESS. It does seem a pity that horse owners are not more considerate to other road users, after all motorists are expected to show consideration to horses and riders by slowing down when passing!!!

Here's looking forward to a CLEANER KENN; HELP TO KEEP BRITAIN TIDY by being CLEAN and TIDY ourselves.

EDITORS NOTE

The article enclosed with the above letter is from the WOMAN magazine. It is

rather long but the following selected paragraphs give the general impression.

'Dog dirt left on pavements and elsewhere isn't only unsightly and a nuisance to passers-by, it's also a health hazard. In extreme cases children can become blind after being infected with toxoplasmosis passed on to them through contact with dog faeces. Accidents can be caused by slipping on it and flies are attracted to the faeces and then move on to goodness knows where to distribute the germs from it. And all of this directly attributable to people allowing their dogs to foul anywhere they please, regardless of other people's comfort or well-being.'

'Dog owners would no doubt be horrified to find a child's dirty nappy left on the ground for them to fall over or step into, so why do they think it's acceptable to leave their pets' mess all over the place.'

'I feel it's time that the Government and local and regional councils started getting tough about this problem. After all, fouling of public places by dogs is an offence, but how many culpable owners have ever actually been traced and prosecuted? Hardly any, of course, which makes the law quite useless at the moment.'

HORSE RIDERS

Would riders of horses in the village please heed this request from householders in Kenn Street - that they do not allow their horses onto the grass verges outside houses. Apart from the fact that this causes destruction of the grass banks and great inconvenience to the householders who have to tidy them up - hidden drains in these verges are sunk below the surface and no doubt a horse tripping on these would be caused serious injury.
