

TRAVELLERS' SITE

On Tuesday 18th February Sam DYER and I went to see the Chief EXECUTIVE of Woodspring District Council about the short-listing of Kenn Moor as one of the Travellers' sites for Avon. Our district councillor, Mrs Greta LEWIS, was able to be with us. We were extremely grateful to both of them for sparing us the time at such short notice for they are both very busy people. The meeting was extremely helpful and constructive. Woodspring's view is exactly the same as our own.

There will, therefore, be a Special Parish Meeting on Thursday 5th March in the village hall at 7-30pm at which a report of the meeting will be given and any further progress reported. A plan of campaign can also be discussed. Mrs Lewis hopes to be present.

The Parish Council realises that this is a very distressing time for everyone and a very emotive subject, but there is a proper procedure to be followed and this has now been set in train.

Please try and come to the meeting.

GIPSY SITE PROPOSALS

Last Thursday a meeting was held on the proposed site for a travellers' encampment in Kenn. For those of you who don't

know it's the 4 acre field between the Droveway and Kenn Pier bridge.

The meeting was well attended by representatives of the National Farmers Union in support of John WITHERS the landowner, by local councillors, by officials of both the Conservative and Liberal Democrat parties from Woodspring and by residents of Kenn, some 200 in all. Local television, radio and press were also well represented.

Mary JAMES of the NFU opened the meeting and introduced Maurice BLIGHT also of the NFU, whose address highlighted many reasons why the choice of this particular site is wholly impracticable. A range of points were covered in Maurice's well researched speech including:-

- the potentially devastating effect on the livelihood of John WITH-ERS, who depends on all of his 36 acres to support a relatively rare herd of 36 short horn dairy cattle and a considerable number of sheep
- the common and well documented problem of travellers' dogs and the disastrous effect they can have on flocks of sheep and lambs
- the close proximity of the proposed site, less than 50 yards from the farmhouse
- the potentially damaging effect on surrounding areas registered as sites of outstanding importance to either nature conservancy, local history or the environment in general.

Maurice finished by pledging his own and the NFU's total and active support in this matter.

A succession of other speakers then took the platform and many further important points were made including:-

the local Conservative party pledged their continuing support in the fight to stop the proposal turning into reality, as did John WYATT on behalf of Jerry WIGGIN, our local MP

- the Woodspring contingent of the Liberal Democrats, including their prospective MP for this area, Brian COTTER, also pledged support and will put pressure on their colleagues in Avon to do likewise
- turning to the physical nature of the site itself, it is impracticable for many reasons; it is bordered on one side by one of the most dangerous water courses on Kenn Moor where a death by drowning has occured in the past school parties would not be allowed access on this factor alone -, the land floods easily, power cables pass diagonally across the site directly contravening the recommendations of the Ministry of the Environment's Guidelines.
- access to the site is at the most narrow and probably most dangerous bit of road in Kenn. This has been the site of numerous accidents
- ⇒ from an environmental point of view the imposition of a large caraven site would be devastating. The field directly adjoins an attractive riverside setting bordered by two of the older cottages in the village typifying the very nature of Kenn Moor itself. It would also be detrimental to the many forms of wildlife and to the recreational aspects provided by excellent fishing
- the sheer scale of what is being proposed must not be underestimated. The site is designated for 8 pitches. One pitch provides standings for 3 caravans. Taking the average 'nuclear' family of 4, this clearly shows the potential for close to ONE HUNDRED extra residents should the proposal succeed and the site be fully occupied. Facilities for the existing 250 residents are considered barely

adequate now

the chairman of Clevedon Town
Football Club, moving to new
pitches nearby explained the
difficulties his club had obtaining
planning permission for club
facilities on the grounds that
sewage and drainage services are
already over-stretched in the area.

It is late already! Our site is now on a short list of only 12 selected from a potential list of over 100. You can help to fight to overturn this proposal by writing your protests as outlined later.

OPINION

It is difficult to see how the proposal to place a large travellers' encampment has proceeded this far. Any rational argument must conclude that the proposal is wholly non-viable. Those who attended the meeting in the Village Hall sometime ago where Avon presented their original proposals will remember that the site now in question appeared very much an outsider because of factors presented very similar to those voiced again last Thursday.

A cynical view might well conclude that once again political interests have come into play. This becomes more believable when the fact that votes cast within the committee set up by Avon to establish the short list were cast as:-

Labour

4 for the proposal

Conservative

4 against the proposal

Lib/Dem

2 for the proposal.

Ms Pat HOCKEY, who is Chairperson of the committee and Mr J BLIZZARD, both Liberal Democrats are those whose votes swung the committee's decision. They are also elected members of Avon County Council where their chosen party holds the balance of power.

The Kenn Pier site directly contravenes almost totally all guidelines issued by the Minister of the Environment for the consideration of travellers' sites. With

the Liberal Democrats declared national stance as 'friends of the farmers' and the blatant disregard of national government guidelines it is difficult to assume that the L/D vote was cast on any consideration other than political.

PROPOSED KENN GIPSY SITE

NOW SHORT LISTED

IF YOU ARE OPPOSED TO THIS, ACT NOW

HOW? By writing THIS WEEK even if you sent an earlier letter a second is essential as the situation is changed and serious.

State the reasons you feel the site is unsuitable. For instance:-

- the land is low lying therefore has a high water table which will pass pollution into the waterways and moors
- the nearby river bank is a leisure amenity area used by fishermen etc
- adverse effect on the farms and other nearby enterprises
- the social effect on our small village community of possibly 50 or more travellers coming to live within the confines of the village
- ⇒ unsuitable road access
- the site is too far away from local schools, health centres etc etc
- → MOST IMPORTANT. Please add your own reasons.

It is suggested you could add great impact if your letter comes from your own solicitor. This would underline to the committee the depth of concern and

opposition to their proposals.

NOTE: You cannot object because you believe the encampment will devalue your property or assets.

NOR: Can you object because you think the presence of travellers in the area may cause a security risk.

FOR INFORMATION the Committee voted

CONSERVATIVES

4 against

LIB/DEM

2 voted with labour

This carried the decision, thereby giving us the PROBLEM.

WORKING IN THE CHURCH

Little did I appreciate the train of events that lay ahead when on a January morning last year I went to discuss with the Rector what work I could do in the Church. At that time I really had no clear idea what was available to an ordinary housewife/part time nurse like me; all I was sure about was that God wanted me to do something more than I was already doing. At John's suggestion I began to explore the non-stipendiary ordained ministry. This means that after a period of training I could become a deacon and work in our parish.

After a great deal of thought, prayer and discussion with Mary WELSH and Richard I decided to pursue the idea. An interview with the Dioscesan Director of Ordinands, a clergyman with special responsibility for organising the selection and training of candidates followed. He arranged interviews with two more clergymen (one brought his wife too) to see if I was suitable to go forward for a national selection conference at which the final decision would be made. It was already after Easter and they recommended that I wait until the following year and spend the intervening time reading to improve my knowledge.

On the Saturday before Christmas I received my summons to attend a selection conference at the beginning of February. Boxing Day found me filling out the numerous application forms, one of which asked for four referees.

Before going off to Woking (where my conference was to be held) I was interviewed by our Bishop, James THOMP-SON, at Wells. With trembling knees I waited for my first ever interview with a bishop. Bishop Jim, as he is fondly known, could not have been nicer and we were soon chatting in a very relaxed way. I left feeling very encouraged.

February 3rd dawned and I set out for St. Columbus House, Woking. The prospect of the next three days and the thought that the rest of my life was to be decided here was more than a little daunting. I was greatly cheered, however, in the knowledge of all the prayers and good wishes for me at home. There were fourteen candidates and six selectors and we all got on surprisingly well given the circumstances! We went through four probing interviews into all aspects of our lives and faith in between discussion groups in which we were observed and a written exercise designed to assess our handling of a sensitive pastoral issue. We even had to take our meals with the selectors so that the scrutiny could con-

tinue.

Although it was the toughest test in my life in a curious way I enjoyed it and found it a stimulating experience. The system although nerve wracking and very probing is the fairest way of assessing suitability for the ministry.

The next ten days were were very hard as I waited to hear the verdict, via the Bishop, but on St. Valentine's Day a letter popped through the door and I was put out of my misery. I was recommened for training!

My next step is to secure a place at the Salisbury School of Ministry for a three year non-residential course. This will involve some weekends away and an eight day summer school each year but the majority of the work will be done at home using a distance learning package with the help of a personal tutor. To give me practical experience in the Church's functions there will be a number of placements in other parishes.

Although the future is going to be hard work it presents a tremendous challenge. For me a new life is certainly beginning in my forties! A lot has happened since that first interview with John and there have been many occassions when I have asked, and do doubt will continue to ask, "what am I doing?" However I know that this is right for me, and that I can do it because God will give me the strength to succeed.

RAY REPORTS

Congratulations to Avril GAUNT on being accepted as an ordinand for the ministry of the Church.

We have to go a long way back to find the last time anyone from Kenn reached this status. If my memory serves me correctly we must go back to 1931, at that time the Reverend William Henry Durante THATCHER was vicar of Kenn or "Perpetual Curate of Kenn" as was his correct title. He encouraged and helped a man called Ernest BEVAN to become a clergyman.

Ernie BEVAN as he was known to many people in Kenn at that time was the husband of Lillian BEVAN the headmistress of Kenn School. Ernie was a keen member of the Church Choir and helped several of his fellow choiristers to learn to read music and gave them voice training.

The Bevans lived at 'School House', Kenn Street, now Moor Lodge.

After a spell of training at a Theological College he was ordained Priest and immediatly accepted a post at Trinidad in the West Indies. While he was practising his ministry there his wife kept on her job at Kenn School until joining him later. Mrs BEVAN was a very popular school teacher.

After several years they returned to England where he became vicar of several parishes in Herefordshire.
